

Message from the National Director



When I joined ProBono.Org in September 2023, I realised that, like many civil society organisations, locally and globally, ProBono.Org has had its fair share of challenges. As it recovers and soldiers on from the effects of a post COVID-19 global crisis, it has to embark on a new wave of change, both in ideas and in the manner we approach the demands of our calling, and be vigilant to new and innovative ways to address access to Justice with social justice impact projects and programmes through the Clearing House Model that it has successfully pioneered since it was established in October 2006.

The forthcoming National and Provincial elections in South Africa in May 2024, will in many ways have a profound and direct impact on addressing societal issues of poverty, inequality, unemployment and the socioeconomic rights challenges that directly impact on the lives of the poor and vulnerable. Through its three regional offices in Johannesburg, Durban, and Cape Town, along with the support of paralegals in community advice centres, ProBono.Org has reassessed and redefined its preparedness and responsiveness to meet social justice imperatives and challenges. This initiative aligns with the National Development Plan (NDP) Vision 2030, the United Nations Sustainable Development Goals (UNSDG) Vision 2030 regarding access to justice, and the African Union Agenda 2063 on the same issue, allowing for a more robust approach. Despite facing constraints in human and financial resources, ProBono.Org remains committed to ensuring that the poor and underprivileged have access to justice, reflecting the transformative principles outlined in Section 34 of the Bill of Rights in our Constitution.

I am of the view that we at ProBono.Org, have to embrace change engagingly and robustly, as I am reminded of the following adage:

Those who ignore change, will perish Those that adapt to change, will survive Those who anticipate change, will prosper and Those who influence change, will transform.

As we travel this journey together to reach out to the most vulnerable members of our society, we need to be constantly reminded that

The friendly greetings on entry of other staff topped it all. It melted my heart. It jolted me to the glaring reality of service in SA.



We have made extensive use of webinars for workshops and seminars in the past couple of years, which has been met with a good response from the profession. It also enables a more national reach.



Johannesburg Office Report

Projects created to address the needs of vulnerable groups.

Children's Project – OCAY (One-Child-A-Year)

The project had a very good year in that it assisted 303 children (a mix of referred cases; cases in which children, their parents or carers were advised; mediation plans drafted and made orders of court; and fun workshops held specially for children during festivals).

Our key partners were the legal practitioners (LPs) who consistently gave of their time, resources, legal services and support. As it is the core business of OCAY to secure legal practitioners representing children in the courts, we match each case with a specific LP. One must appreciate that when the courts came to a standstill during the COVID-19 pandemic, it resulted in an almost insurmountable task to catch up with the backlog created. However, the LPs bravely pushed on, even though Children's cases - being challenging in nature - take a long time to reach conclusion, and require numerous, and usually monthly, court appearances. The project referred 36 cases and closed 29 cases which the LPs concluded successfully. The project's staff



assisted 60 children and their families with legal advice and support (the so-called once-off cases).

One of the attorneys, Ms Heather Pretorius from Fiona Marcadonatos Inc. dealt with a case from December 2019. It was a Johannesburg Children's Court case in which the father claimed primary care of their one-year-old son. Ms Pretorius acted for the mother, opposing the application. Apart from dealing with the case throughout COVID 19, she appeared monthly, religiously reporting back on the progress of the case, until she finally obtained a court order in the child's best interest in April 2023.

The second group of key partners was the mediators. The mediation project in the Protea Children's Court in Soweto was started by the project manager and Rev Leon Forsman. Adv JP Weitz assisted on a regular basis. When Rev Forsman was called to a congregation in KZN, Therèsa Luyt and Karen Malan took charge. They extended the project to include additional mediators to run the project regularly on Wednesdays. It also provided training opportunities to other mediators who needed their final practical experience. For the period of 13 May 2023 to 13

September 2023, the mediators mediated 116 cases, of which only 12 were unresolved. The remainder had parenting plans concluded and were referred back to be made orders of court. The team gave approximately 248 hours of free mediation service to 249 adults and 150 children.

The project manager went with the mediators

to the Master dealing with deceased estates in Johannesburg. They offered the mediation service to the Deceased Estates department, which accepted the offer in a very positive manner. The department did not make any referrals but liaised with the OCAY project upon its request.

The mediators presented basic mediation skills

training to 42 teachers. The reasoning was that 40 teachers with an average of 30 learners would easily reach about 1200 children each day. This should have a large and continued impact, improving the lives of children. The training took place over two separate sessions. It was clear from the teachers' feedback that their skills were strengthened and that they would be in a much better position to deal with and solve conflict.

The project further trained seven community leaders. Feedback by this group was also very positive and a need for training regarding the division of the joint estate after divorce was identified. Six community leaders participated in this training.

Since the pandemic, virtual training and virtual meetings remained the preferred option for the LPs. Unfortunately, the ongoing unstable electricity supply interrupted Wi-Fi access for many webinar attendees. The project trained 80 LPs in Children's Court practice.

Cooperation with target groups

The project's stakeholders supported the activities of the project very well. We would like to thank the LPs who accepted cases, and who presented webinars and in-person training; the mediators who diligently continued with their work at the Protea Children's Court; the magistrates and clerks at several Children's Courts; the senior Family Advocate from the Pretoria office providing support in various ways; and the Constitution Hill educators who provided assistance and infrastructure during training and festival events. Apart from focusing on children, the project

manager assisted with training final year LLB students from Varsity College. Groups of students had to undergo their practical work experience at the High Court in Pretoria. Each student had to complete 24 hours with ProBono.Org. The manager exposed them to the socio-economic woes of members of the public and how that affected the rights of children. The students had the opportunity to visit a judge in the Palace of Justice; sit in at various court proceedings; assist with administration for the Legal Practice Council (LPC) with which ProBono.Org partnered; and had to undertake short assignments that integrated theory with practice. In their four sessions of six hours per session, one group of four students consulted 46 clients, winning an award for the best performing student group at the Pro Bono Awards.

When the Legal Practice Act came into effect in 2014, compulsory pro bono work was not provided for. Since the regulations on 40 hours of yearly compulsory community service were gazetted on 11 August 2023, to come into effect on a date in 2024, ProBono.Org will have a much broader base of LPs to access. ProBono.Org (currently the only clearing house for the legal profession) started its planning to regulate, organise and channel pro bono work for the legal profession. With a new

National Director appointed from 1 September 2023 at ProBono.Org, impact services will become part of the strategic execution of our vision and mission. A new and exciting time began, which will ensure extended services to the children served by the OCAY project.

Family house project

The panel of experts has been meeting monthly to put together a funding proposal (to Oxford University) for the work we are embarking on to advocate for the realisation of the family house. One of the members is a lecturer from Oxford University, who undertook his research thesis in South Africa, at ProBono.Org, analysing the Master's clinic – the system of inheritance and formal definition not being applicable to black South Africans to allow them to realise the family house in law.


Refugee project

We have had workshops in Polokwane and Musina with civil society organisations and members of the community educating them on refugee law, the rights of refugees, and guaranteed access to civil rights such as education, health care and birth registration.

We are in the process of putting together a class action to assist many of our clients, mainly fathers who are unable to register their children's birth because the mother of the child is a foreign national, most of the time from Zimbabwe, is undocumented or has expired documentation. We will rope in the expertise of the Polokwane advocates in terms of our MOU with the Polokwane Bar.

Gender-Based Violence & Femicide (GBVF) Project

The aim of this project is to reduce the instances of gender-based violence and femicide in South Africa by providing free legal services and conducting community workshops targeted at vulnerable women and children. This project also aims to upskill legal practitioners in dealing with cases related to gender-based violence. Through this project, we have assisted over 150 clients.



Community Advice Office (CAO) Support Project

ProBono.Org supports six community advice offices run by paralegals in townships around Gauteng with the support of the C S Mott Foundation. These are located in the areas of Kagiso, Soweto, Orange Farm, Mabopane and Tembisa.

Working with the CAOs allows us to have a wider reach into more peri-urban areas where we do not have offices and to assist the CAOs in a small way to meet their running costs.

The paralegals play an important role in being an accessible source of legal assistance to their community members and they refer cases to us which require the services of an attorney.

We also hold a number of joint meetings with the CAOs throughout the year at which they share their challenges and experiences with us and with each other.

Our training programme for communities includes those served by the CAOs, who attended a number of workshops during the year, including a housing workshop in October dealing with property ownership, and 16 Days of Activism events on GBV, protection orders, rape and sexual harassment.

Durban Office Report

I am pleased to present the annual report for ProBono.Org Durban, for the year 2022 to 2023. It has been a year of growth, impact and meaningful engagement with our community.

Throughout the year, ProBono.Org remained committed to our mission of providing access to justice for all. We are proud to announce that we served a total of 1,490 clients across various legal matters. Each client represents a unique story, and it is our privilege to assist them in navigating the complexities of the legal system.

In our efforts to raise awareness and empower individuals with legal knowledge, we held 24 community seminars. These seminars served as platforms for education, discussion and dialogue on critical legal issues. We were thrilled to welcome 632 attendees at these workshops, fostering a sense of community and understanding within our region.

Recognising the importance of accessible digital platforms in reaching a wider audience, we conducted seven Facebook Live sessions. These sessions provided valuable insights into legal topics, with over 1,000 views. Through social media, we aim to bridge the gap between legal information and the communities we serve, ensuring that everyone has access to essential legal resources.

Collaboration with legal professionals is integral to our work at ProBono.Org. In the past year, we organised 15 attorney workshops, facilitating discussions and training sessions on pro bono work and legal ethics. These workshops attracted over 300 attendees, highlighting the dedication of legal professionals to serving their communities.

As we reflect on the achievements of the past year, we are inspired to continue our efforts in the pursuit of justice and equality. In the coming year, ProBono.Org remains committed to expanding our reach, enhancing our services, and advocating for the rights of all individuals.

I would like to extend my sincere gratitude to our dedicated team, volunteers, partners and supporters who have contributed to our success. Together, we have made a meaningful difference in the lives of many.

Cape Town Office Report

The Cape Town office is proud to report that it has made strides in engaging with the big law firms and prominent public interest law organisations (PILOs) to increase its profile and impact.

Key Achievements

ProBono.Org staff attended venues in Gugulethu and Athlone to consult with clients during Access to Justice Week in August in collaboration with the Department of Justice and Constitutional Development, the South African Women Lawyers Association and the National Association of Democratic Lawyers.

ProBono.Org facilitated Wills Week with its panel legal practitioners to assist indigent clients in September 2023.

In an effort to support survivors of gender-based violence, the Cape Town office has hosted a number of legal education workshops at the Saartjie Baartman Centre for Women and Children:

- 16 November 2022: Protection Orders (Spousal & Non-Spousal Abuse) and Consequences upon Divorce (Cohabitation and Universal Life Partnerships)
- 29 March 2023: Social Grants

• 31 May 2023: Status of Muslim and Customary Marriages

- 28 June 2023: Parental Responsibilites and Rights (Children's Court procedures)
- 14 August 2023: Domestic Violence with a Focus on Non-Physical forms of Abuse
- 29 August 2023: Spousal and Child Maintenance

ProBono.Org hosted various legal clinics in Bonteheuwel throughout the year in collaboration with the Bonteheuwel Walking Ladies.

We had a monthly radio interview series with Radio 786 where various legal practitioners presented on legal topics for the benefit of their listenership.

We had a positive relationship with Varsity College where 4th year students were provided an opportunity to consult with clients and to assist clients paralegally.

Lipco collaborated with ProBono.Org to present in Atlantis and Paarl on 22 November 2022 and 3 August 2023 on Gender-Based Violence & Maintenance. We collaborated with Norton Rose Fulbright to host a webinar series for legal practitioners to discuss topical issues such as "Residential & Commercial Evictions" and "Corporate Governance".

On 26 September 2023, Mosaic collaborated with ProBono.Org to present workshops on Gender-Based Violence in relation to Marriage and Divorce. The workshop was aimed at GBV survivors.

We had a successful Family Law Series collaboration with ENS Africa and the *Womens Legal Centre* in Mitchell's Plain. The first workshop dealt with rights relating to abortion. The series continued in October and November 2023 and dealt with marriage and divorce, parental rights and responsibilities, child maintenance, abuse and legal recourse.






