2024 Cape Town ProBono.Org Awards

The Cape Town office of ProBono.Org celebrated its Annual ProBono.Org Awards on 13 November 2024 to commend the outstanding pro bono work done by its volunteer legal practitioners and partners in 2023 and 2024. The Awards Ceremony celebrates the contributions of attorneys, advocates, Non-Profit Organisations, Community-Based Organisations and public servants as it recognises the multi-stakeholder approach required to achieve access to justice for all. Oftentimes, the downtrodden, marginalised and vulnerable are left to struggle alone when facing seemingly insurmountable legal disputes which may lead many people to believe that the enforcement of constitutional rights (especially in civil matters) is a pipe dream. This belief is further perpetuated by the increasing inequalities in our society coupled with the high cost of legal services. However, the everlasting hope burns within each and every winner awarded during the ceremony that compassion and justice are still alive.

Judge Siraj Desai, the Legal Services Ombud, delivered a riveting keynote address that made clear that South Africa's hard-earned triumph against the apartheid regime could not have been achieved without pro bono legal assistance. Judge Desai emphasised that although we are 30 years into our constitutional dispensation, pro bono legal assistance is needed now more than ever considering the vast socio-economic disparities found in our society. Judge Desai urged legal practitioners to relook at their fee structures and to render their services ethically in order for all seeking legal assistance to be treated fairly no matter their economic background.

ProBono.Org awarded those who went above and beyond to volunteer their time, efforts and expertise to uplift and empower. Attorneys, advocates and mediators on ProBono.Org's panel take on matters, present workshops, staff legal clinics as well as present webinars for the benefit of those in need. In doing so, people who once did not have access to justice get an opportunity to engage meaningfully in our legal system.

A message from the National Director, Mohamed Shafie Ameermia



I would be remiss if I did not thank Mr. A.B. Moosa, CEO of the Avalon Group of Companies, who provided ProBono.Org free use of all their countrywide cinemas to all ProBono. Org patrons and donors, to enjoy some insightful social justice impact movies.



Since my appointment as National Director, we have embarked on some public interest law litigation. We used our clearing house model to engage the legal services of Norton Rose Fulbright SA Inc., the Commission for Gender Equality (CGE) and the Office of the Presidency of the Republic of South Africa, to assist Caster Semenya, our iconic athlete, to access her rights and be properly represented in the Grand Chamber of the European Court of Human Rights in Strasbourg, France, on 15 May 2024.

Later in the year, ProBono.Org once again helped to provide the 77 victims of the fire at the Usindiso building in downtown Johannesburg with legal assistance from Norton Rose Fulbright SA Inc. Grateful thanks to Andy Chinnah, a civil rights activist, and the Centre for Applied Legal Studies (CALS), who made the facility at the University of the Witwatersrand available for consultations for these victims who later appeared before the Khampepe Commission of Inquiry which eventually held the City of Johannesburg liable for the disaster.

Once again, our strategic partner Ashraful Aid generously provided food to the Usindiso fire survivors for the duration of this long and difficult case.

Despite a successful outcome in favour of the victims, they continue to face hardships to vindicate their rights. For the victims and their loved ones, the road ahead is unfortunately a long one, but we continue with fortitude and fervour to secure their rights to live in equality and dignity.

We look forward to the new year and beyond, alive with its challenges and opportunities. We are hopeful that in the strides we have made in 2024, the organised legal profession, the diplomatic and the donor communities will actively support ProBono.Org and join hands with us to make Access to Justice for all a lived reality.

A special thank you to all the staff, interns and volunteers at ProBono. Org for their selfless contributions. Your efforts help to make us successful in serving humanity with dignity to live in freedom and equality.

International Children's Day

On 2 November 2024, the One Child A Year (OCAY) Project at ProBono.Org Johannesburg collaborated with Constitution Hill and LALELA Life Changing Art to commemorate International Children's day under the theme "One child at a time, each child matters all the time."

giving children and their parents a unique opportunity to explore this iconic site and learn about its importance in South African history.

16 Days of Activism for No Violence Against Women and Children



ProBono.Org Durban commemorated the 16 Days of Activism for No Violence Against Women and Children from 25 November to 10 December 2024, with several impactful activities aimed at raising awareness and providing support.

On 27 November the Durban office hosted a special help desk at the Point Magistrates' Court, focusing on assisting clients in the domestic violence section with legal support. Additionally, the team conducted radio interviews to discuss the socio-economic impact of gender-based violence and the legal avenues available for survivors.

Further community engagement took place on 5 and 6 December. ProBono.Org Durban hosted seminars at a women's shelter and in the semi-rural area of KwaNdengezi to educate and empower local communities, raising awareness about the importance of combating genderbased violence and the resources available for those affected.



Maintenance help desk opened at Cape Town Regional Magistrate's Office

In alignment with the 16 Days of Activism Against Gender-Based Violence campaign, ProBono.Org is proud to announce the launch of the Maintenance Help Desk at the Cape Town Regional Magistrate's Court which took place on 5 November 2024. This helpdesk aims to provide much needed legal assistance to individuals navigating maintenance related challenges, ensuring greater access to justice, especially to the most vulnerable members of our society. Moreover, this initiative addresses a critical yet overlooked form of abuse - financial abuse - which is a prevalent aspect of Gender-Based Violence (GBV).

Financial abuse occurs when abusers control or withhold financial resources, leaving victims trapped in cycles of dependence unable to break free from abusive relationships. For many of the help desk clients securing maintenance orders for themselves or their children, maintenance is not just a legal battle but a vital step to reclaiming their dignity and financial independence.

The Maintenance help desk provides the following assistance to those affected by financial abuse:

- Assistance with drafting and filing maintenance applications
- Guidance on enforcing existing maintenance orders on non-compliant parties
- Other legal advice and support to clients navigating the legal system where maintenance and genderbased violence is concerned.



knowledge to secure financial support, this help desk plays a pivotal role in breaking the cycle of abuse in Cape Town and surrounds. It also ensures that parents, guardians and dependants have the opportunity to build safer and stable lives.

We commend the legal practitioners who have staffed this help desk by volunteering their time to this cause and the Cape Town Magistrate's Court for its collaboration in making this service a reality. Together we are working towards a society where legal assistance and justice is easily accessible, and financial abuse is no longer a barrier to freedom for survivors of GBV.



A Success Story

A mother reached out to our ProBono.Org offices in Johannesburg to seek assistance in relation to a notice of birth for her child. The mother's asylum seeker permit had expired at the time she gave birth. She informed the hospital that she had applied to renew her permit but the hospital would not give her the notice of birth/proof of birth. When her asylum seeker permit was renewed, she went to Home Affairs to register the child's birth. They requested the proof of birth. The mother went back to the hospital to request the proof of birth. She produced the renewed asylum permit and they asked her to pay a fee of R15 000.

The mother approached ProBono.Org for assistance. Our staff attorney, Aphiwe Nonyukela, wrote to the hospital for the proof of birth which the hospital gave her. ProBono. Org is relieved to have assisted the mother to obtain this important document. Hopefully this will assist the mother to register the child's birth at Home Affairs.
