## **Human Rights Festival 2024**

ProBono.Org participated in the annual Human Rights Festival at Constitution Hill from 21 to 24 March 2024. Our team was invited to share a stall with the Johannesburg Society of Advocates and Norton Rose Fulbright. The advocates and candidate attorneys from Norton Rose Fulbright joined by the interns from ProBono.Org spent the three days explaining the services they provide through ProBono.Org to the community members and visitors and reiterated their common purpose of making legal assistance accessible to all.

#### Children's Project -Dialogue on Sexting

On 23 March 2024, ProBono. Org in collaboration with Media Monitoring Africa (Web Rangers), the Johannesburg Central Education District, the Gauteng Department of Social Development and the Teddy Bear Clinic facilitated a dialogue on sexting and the consequences that these internet grooming acts have on the lives of children. This discussion was meant to inform parents, teachers and community members of the dangers of the content consumed on social media and how it affects the lives of innocent children. They highlighted the challenges faced physically, mentally and psychologically.

The panellists reiterated the importance of these conversations for parents and teachers so that they are in a position to protect children, especially girl children because they are the ones facing the stigma if a pregnancy occurs. They further discussed the rights that children have. Mrs. Daphne Naidoo from the Department of Social Development discussed the rights (with limitations) regarding access to contraceptives, access to facilities for termination of pregnancy and for child maintenance.

# Celebrating 30 years of democracy: 30 cases, 30 lawyers for 30 years of democracy By Hellen Motau, Communications Intern



2024 marks South Africa's 7th democratic elections. This equates to 6 five-year terms, adding up to 30 years of democracy.

Our campaign of 30 Cases, 30 Attorneys for 30 Years of Democracy seeks to encourage legal practitioners to perform their pro bono duties in their respective practices to celebrate this milestone of our constitutional democracy. ProBono.Org is campaigning for more attorneys to sign up to our panel of volunteer practitioners.

According to StatsSA, an estimated 10.7 million people were employed in the formal nonagricultural sector in the fourth quarter of 2023. Most people in this country rely on social grants to get by. So, what happens when they find themselves unfairly dismissed, threatened with eviction, experience domestic

violence or are unable to register their children in school because they are undocumented minors? That is where ProBono.Org steps in to help by providing access to a private lawyer at no cost.

As the only legal clearing house in South Africa with only three offices around the country, ProBono.Org is burdened with hundreds of requests daily. We link clients with private legal practitioners to assist with civil matters such as divorces, deceased estates, refugee law, wills, child law, housing and labour law. excluding criminal cases, RAF, institution of evictions, contractual claims and tax. By consulting with the clients and drafting case memorandums our service removes much of the administrative burden and saves time for the attorneys and counsel. We have received a total of 798 cases between January to

March and are in desperate need of legal assistance across our three offices.

We hope that this initiative will encourage more legal practitioners to assist us in trying to improve access to justice for the vulnerable and marginalized. We will then use our social media platforms to profile the successful cases.

## Egoli Gas (Pty) Ltd v Kensington Residents' and Ratepayers Association (KRRA) By Aphiwe Nonyukela, Staff Attorney, Johannesburg

ProBono.Org has committed itself to taking on some social impact cases. Amongst these is the Egoli Gas (Pty) Ltd v KRRA case. We would like to thank Baker McKenzie for taking on this matter on a pro bono basis. Baker McKenzie will be the attorneys on record for the Kensington Residents and Ratepayers Association.

This is an urgent direct application to the Constitutional Court to appeal the decision of the Gauteng Local Division of the High Court after it dismissed an application (with costs) for an urgent interdict against Egoli Gas.

On 6 September 2023 Egoli
Gas gave a 30-day notice of
termination of the supply of piped
natural gas to the suburb of
Kensington and residents of the
suburbs of Bertrams, Malvern and
Bezuidenhout Valley.

On 19 September a second notice was sent out which purported to extend the initial notice.

On 6 October 2023 Egoli Gas notified the affected households of an extension to 31 January 2024. The supply of piped natural gas to the affected households was historically provided by an organ of State, the Municipality, or an entity under its control, from 1892 to 2000, but since 2000 has been provided by Egoli Gas after the municipal entity that performed this function was sold to Egoli.

A two-part urgent application was brought by the KRRA in the High Court seeking relief against Egoli Gas.

- Part A an interim interdict to prevent Egoli Gas from terminating the supply of natural gas to affected households.
- Part B to review and set aside the decision to terminate the supply of natural gas to the affected households. The High Court dismissed Part A of the application and found that the onus was on the KRRA and not Egoli Gas in terms of \$22 of the Gas Act to have shown that the termination of services was not objectively justifiable.

Although the High Court dismissed Part A of the application, is not the end of the road for the KRRA. They remain hopeful for a finding that the actions of Egoli Gas were indeed unlawful and unconstitutional.

Our commitment to social justice compels us to take on and refer such matters that impact on the constitutional rights of individuals and communities. ProBono.Org will continue to oversee the legal process of this case to its finality and will provide updates on any developments on its website and social media pages.

## **Usindiso:** Help after the fire on 31 August 2023

The Social Impact Team at Norton Rose Fulbright were approached on 20 September 2023 to represent at the Khampepe Commission of Inquiry the residents of the Usindiso Building in Marshalltown after the fire that occurred on 31 August 2023.

We met with representatives of the residents on 23 September. We spent five hours consulting with the representatives of the residents as they told how they came to be living in the building, what the conditions were like prior to the fire, the events of the night of the fire and what has happened since.

From 26 September to 9 November 2023 we consulted with approximately 340 of the victims. The first week was spent at our offices in Sandton, where we received assistance from legal and non-legal staff in the office to make sure that our consultations were completed.

We then moved the consultations to the FNB building on the Witwatersrand University campus to conduct the rest of our consultations with the assistance of members of the public, interns from ProBono.Org and the Centre for Applied Legal Studies (CALS).

The interns were wonderful as they arrived early every morning, eager to assist and consult with the clients. The venue was perfect, because it was closer to the inner city, which was more convenient for the clients than having to travel to Sandton.

With the assistance of ProBono.Org we received donations of cooked meals, tea, coffee and biscuits from an organisation called Ashrafulaid. This was much appreciated as it

was often the only meal the clients received during the day. We believe that this also assisted in giving them a sense of dignity and respect as they had the difficult task of recalling the traumatic events of the night of the fire and watching their loved ones die.

The mammoth task of possibly consulting with up to 500 victims of the fire was turned into a manageable task due to the assistance we received from ProBono.Org, CALS and Ashrafulaid. In the first week of our consultations in Sandton, we consulted with 100 clients. At the FNB building, with the help of between 15 to 20 volunteers a day, we were able to consult with 240 clients.

On 15 November 2023, we received frantic calls from some of our clients staying at the Holfland Community Centre in Bezuidenhout Valley. We were informed that representatives from the City of Johannesburg, JMPD, SAPS and the Department of Home Affairs had arrived to 'evict' our clients from the shelter, as it had been earmarked as a voter

registration centre. Our clients were rounded up, the South Africans transported to Denver Shalazile informal settlement and the foreign nationals were arrested and detained at the Jeppe Police Station.

On 16 November 2023, representatives from our office went to the Jeppe Police Station to consult with our clients and were met with resistance. Our clients were transported to Johannesburg Central Magistrates Court and brought before Senior Magistrate du Plessis for him to make an order in terms of Section 34 of the Immigration Act, declaring our clients deportable for not being in possession of documentation. We requested that proceedings be stayed until 17 November 2023, as we were launching an urgent interdict application in the Johannesburg High Court, and if we were successful the Department of Home Affairs would be interdicted from deporting our clients because, as victims of the fire, they were valuable witnesses in the Khampepe Commission of Inquiry.

On 20 November the Magistrate

found that our clients were deportable and should be deported within 30-days of the judgment, as prescribed by the Immigration Act. The urgent application was heard before the Honourable Dosio J on 23 November 2023. In the meantime, the 32 who had appeared before the Magistrate were transported to the Lindela Repatriation Centre. During the urgent application the City of Johannesburg entered into a settlement agreement with the residents to improve the conditions at the Denver informal settlement. The matter proceeded on the issue of the detention and deportation of those held at Lindela and judgment was reserved.

On 7 December 2023 we received the judgement in the urgent application and our clients succeeded. The Department of Home Affairs was interdicted from deporting our clients until the Commission of Inquiry had made its findings. The

settlement agreement between our clients and the City of Johannesburg was made an order of court.

One must ask the question though where are our clients now? Those at Denver face many challenges. Many of our clients have not been allocated one of the temporary shacks. The shacks were built on a parking lot, at the bottom of a slope, so during the summer rains there has been severe flooding. There is no longer security at the informal settlement and others desperate for shelter or who want to use the shelter for their own purposes are forcing their way in. Those at Lindela remain in limbo and often complain about the inhabitable conditions. They are forced to live in overcrowded rooms, are feasted on by bed bugs, they are having difficulty accessing medical attention and are only provided two meagre meals a day.

Our team has dedicated its time and energy to assisting the victims

of the Usindiso fire through legal representation at the Commission of Inquiry and in our Courts. We are grateful for the assistance of ProBono.Org, CALS and other legal entities, civil organisations and groups for their support and help. We have become usindiso wabantu – the help of those in the aftermath of the fire that occurred on 31 August 2023.

The Commission of Enquiry gave all parties the opportunity to make oral closing submissions which was to highlight the written submissions that were filed on 28 March 2024.

All parties addressed the
Commission, which included
SERI, the Johannesburg Fire
Victims Support Group, the City of
Joburg and the evidence leaders.

The Commission will now deliberate and will provide recommendations at the end of April 2024. ●
