Congratulations on 40 years in the legal profession -

Elsabe Steenhuisen, Manager of the ProBono.Org Children's **Project**

3 July 2024 marked 40 years since the High Court in Pretoria, the then Transvaal Provincial Division. admitted me as an advocate. In 1984 the RAU Law Clinic (now UJ) required an admitted practitioner to assist at one of the law clinics on a parttime basis. I fit the bill as I had been one of its law clinic students two years before and preferred having flexitime, looking after our first born.

So, my career started as a clinician and academic, whilst being allowed to take on private work. In 1990 I became the director of the RAU Law Clinic until 2007 when I resigned to accompany my husband to the USA. Both my contributions and functions at the university were diverse in nature, duration and exposure. Apart from running different law clinic offices at different times; teaching law of civil procedure; being responsible for designing both the practical



and theoretical components of the final year LLB subject, Applied Legal Studies; and overseeing four law clinic offices with their staff and students, I had to raise funds. Together with two of my clinic colleagues and one secretary, we designed a handsome lucrative two-year paralegal diploma in 2000, which is still ongoing.

Besides my academic role as senior lecturer and obtaining the LLM degree in 1995, I had many responsibilities as a director and participated often in high level managerial planning at the university.

Upon our return from the USA in 2009, I gave training at the Johannesburg Bar; LEAD; different law firms; and to SASSETA paralegals, whilst practising in family law and mental health law. Upon securing permanent residence in Canada, I completed the Canadian LLB in 2016. I volunteered my services to

ProBono.Org in 2012 and, until the end of 2018, ran the Johannesburg divorce help desk once a week with students enrolled at LEAD. Since 2012 I was involved at various help desks of ProBono.Org and in June 2016 ProBono.Org appointed me as a legal consultant on its children's project.

When looking back over one's career, one does realise what and who shaped it. Apart from my Christian upbringing , two communities played a central role: the diverse rural highveld communities in the then Eastern Transvaal - Brevten, Carolina and Ermelo – and the urban Rand Afrikaans University in Johannesburg. Principles of hard work, honesty, ambition, life-long learning and good citizenship were central to all. School and university mottos like "Werk en dien" (work and serve); "Non veribus sed vertute" (not

by strength but by virtue), and "Diens deur kennis" (service through knowledge) imprinted the principle of service to others and the wider community. Upon taking the oath as counsel in 1984, the notion of justice became the benchmark in fulfilment of duty and influenced the exercise of

choice in my personal and professional life.

Human rights took on a new meaning when the Constitution came into effect, highlighting the vulnerability of the poor, the marginalised and the children, and the responsibility on us as legal practitioners. "Pro bono for all" presented its own challenges, often being a changing, slippery notion, stingy in presenting a successful remedy for each client. Such is legal practice - hard, tough, soulwrenching, but also highly rewarding and often humbling. As a first-year law student in 1978 I wrote to my parents: "ius est ars boni et aequi" and today I

confirm that to me the law is still the art of goodness and fairness.

I am grateful for a blessed legal career and thank everyone whose path I have crossed over the years.•

Attorney Refugee Law Training 2024

On 19 July 2024, ProBono.Org Durban, in collaboration with HIAS South Africa practitioners, candidate legal practitioners and paralegals. The purpose of the event was to capacitate the pro bono panel to assist ProBono.Org with refugee law matters.

The event commenced with a welcome address from Alana Pugh-Jones Baranov, Country Director for HIAS South Africa. She outlined the role and mandate of HIAS South Africa in providing essential services and legal protection for asylum seekers and refugees, highlighting their partnership with ProBono.Org in refugee projects.

Dr. Hupenyu Makusha from the Catholic Archdiocese of Durban Refugee Pastoral Care delivered an insightful presentation on the needs and challenges faced by refugees in South Africa, providing a crucial social context for the attendees.

The programme continued with an overview of the Refugees Act (130 of 1998), focusing on the asylum seeker process and principles of international

refugee law, presented by Mellisha Hurchund from Mellisha Hurchund Attorneys. Nyiko Manyusa, Head of the Lawyers for Human Rights Durban office, gave a detailed presentation on the role of the Refugee Appeals Authority of South Africa and the mandate of the Standing Committee for Refugee Affairs in reviewing applications, certifications and withdrawals of refugee status. He also highlighted the issue of unlawful arrests and detention of asylum seekers and their efforts to hold the Department of Home Affairs accountable.

Advocate Senzo Luthuli from the KwaZulu-Natal Society of Advocates concluded the event with a presentation on the Promotion of Administrative Justice Act (3 of 2000) and provided attendees with practical drafting tips.

The HIAS-ProBono.Org refugee project aims to expand its reach in providing free legal assistance to asylum seekers and refugees. To achieve this goal, ongoing training of legal practitioners is essential. We encourage all attorneys on our panel to attend our training workshops and take on refugee law

matters.

Mediation Training for Teachers By Elsabe Steenhuisen, Children's Project Manager

ProBono.Org and the mediation Network Africa teacher training programme.
The goal of the training was to empower teachers on various methods of conflict resolution that could be held between learnersteachers and teachers-parents. In attendance was a vast network of 34 Life Orientation teachers from schools throughout the Gauteng reg ion.

ProBono.Org provided a brief legal insight on the applicable rights in cases of child pregnancies. In terms of the Choice on Termination of Pregnancy Act, females under the age of 18 can obtain an abortion and receive contraceptives without parental consent. However, if the female is under the age of 16, a health care provider has a duty to report the abortion to the National Department of Health.

Theresa Luyt from the Mediation Network Africa facilitated the training. She highlighted childhood trauma as being a contributing factor, explaining to the teachers that such trauma can result in an array of mental illnesses, including depression and other personality disorders. She trained the teachers on the various symptoms to look out for while interacting with their learners.

Ms Luyt explained that
the Children's Act and the
Constitution expressly provide
for the best interest of the child
in all child-related matters. She
unfolded formal family mediation
(FFM) as a process where a
mediator assists parties in
resolving a dispute void of conflict.
Mediation is often used to resolve
conflicts in various contexts,
including conflicts within the
school environment.

The teachers received resources which they can refer to when conflict arises in their schools. They were also provided with extra conflict-related content to use in practice. When a dispute arises relating to a pregnant learner, the options available are: termination of the pregnancy; placing of the child in a foster

home; or adoption. Further, the prospective parents/guardians can conclude a parenting plan. A parenting plan agreement is a written document that outlines the arrangements for the care and upbringing of children after a separation or divorce.

A roleplay scenario was introduced to the teachers to provide them with a practical opportunity to implement their conflict resolution skills. The scenario included a pregnant learner who had had sexual relations with one of her classmates. The teacher noticed the pregnancy and approached the learner. The exercise aimed to establish how the teachers would mediate between the learners involved and their parents. The teachers were fully engaged in this exercise and had an opportunity to exercise the skills they had acquired during the training.

The training was a remarkable success. Many teachers expressed a wish to receive similar training in different alternative dispute resolution matters.

an applicant's circumstances must fit within the scope of Section 3 of the Refugees Act (130 of 1998), namely, that the applicant must have a "well-founded fear of persecution". In recent years, South Africa has seen an increase in the number of refugees and asylum-seekers seeking protection within its borders, particularly from conflict-affected countries in the region. The Refugees Act plays an important role in ensuring these individuals are able to access the protection, support and services they need to rebuild their lives and integrate into South African society.

On 21 June 2024, Refugee Pastoral Care (Catholic Archdiocese of Durban) together with ProBono. Org Durban, Lawyers for Human Rights, Africa Unite, Refugee Social Services, Church World Service and HIAS South Africa hosted a World Refugee Day Commemoration for the asylum seeker and refugee community at the Denis Hurley Centre in Durban. The event was refugeefocused and sought to raise the voices of asylum seekers and refugees. The event began with a welcome address from Dr Hupenyu Makusha from Refugee Pastoral Care, as well as music

Emphasis was placed on the need for refugees to take the initiative to integrate into their new communities. It was acknowledged that more work needs to be done to provide social and legal support for asylum seekers and refugees. In light of the above, we encourage private legal practitioners to join our panel to take on our refugee

Our event was aimed at celebrating and honouring refugees and the response we received from the community shows that we achieved our purpose. Community members came out in their numbers. There were performances by the Youth Group from Purpose Driven Ministry and a very touching performance from the Refugee Group. This all reminded us that we need to treat each other with humility and kindness.

A social worker from the Department of Social Development spoke on the services that they offer and that these services also extend to refugees. We also had a representative from the Department of Health who stressed the importance of building inclusive healthcare systems. We were also joined by various stakeholders such as Future Families, the Red Cross, International Organisation for Immigration

and the Outreach Foundation.
